

# Data Protection

Our company **Lucky angel, s. r. o.**, with its registered seat at Nedbalova 17, 811 01 Bratislava - mestská časť Staré Mesto, Slovak Republic, ID No. (IČO): 47 113 413, registered with the Commercial Register of District Court Bratislava I, Section: Sro, Insert No.: 88697/B (the "**Company**") collects and processes personal data in the performance of its activities.

## 1 Guiding principles for the processing of personal data

The guiding principles for the processing of personal data by our Company are purposefulness and security. We collect and process personal data only for the purposes, to the extent and for the period necessary for the performance of our activities. At the same time, we place great importance on the security of each person's data and have therefore put in place appropriate technical and organisational measures to protect this data and to ensure a sufficient level of security appropriate to any relevant risks.

## 3 Rights of the data subject

For quick reference, we also provide below an overview of the basic rights of data subjects (i.e. persons whose personal data are processed), as well as some useful advice on how these rights can be exercised towards our Company or the relevant public authority.

In relation to the processing of personal data, data subjects have the following rights:

- the right to request information about whether the Company processes such personal data
- the right to request a copy of such personal data processed by the Company
- the right to rectification of personal data
- the right to erasure of personal data (the so-called right to be forgotten)
- the right to restrict the processing of personal data
- the right to object to the processing of personal data (in some cases of processing)
- the right to withdraw consent given for the processing of personal data (if applicable)
- the right to transmit the personal data (i.e. the provision of personal data in a portable format and their possible transmission to a person designated by the data subject)

## 4 Method of exercising the data subject's rights towards our Company

With regard to the processing of personal data by our Company, data subjects may at any time exercise their rights electronically by sending a request by e-mail to: [[michal.pasko@residencefk.com](mailto:michal.pasko@residencefk.com)].

In order to verify the identity of the data subject and to make sure that the person contacting us and claiming data subject rights is in fact the data subject or a person authorised to act on his or her

behalf, we may, for example, first ask for the relevant proof of identity of the applicant and the data subject concerned in a first response to a written request.

## **5 Communication between the data subject and the supervisory authority for personal data protection matters**

In addition to the above rights, data subjects may also lodge a direct complaint regarding the processing and protection of personal data by the Company with the Office for Personal Data Protection of the Slovak Republic.
